Pathways into care

Various categories are merged:

- "Unknown no documents available or not identifiable in the documents" (41 survivors) and "Unknown did not know or not identifiable in the documents" (31 survivors) into "Unknown"
- "Psychiatric" (5) and "Psychiatric unknown" (27) into "Psychiatric Unknown"
- "Taken away by CYFS" (39) and "State requirement Unknown" (51) into "State requirement Unknown"

The "Other" category was removed, and the data was cleaned of any invalid records.
