

#### **MINUTE 17**

## DIRECTIONS ON HOSPITALLER BROTHERS OF ST JOHN OF GOD PUBLIC HEARING

## **27 JANUARY 2022**

1 This Minute sets out directions on the Royal Commission of Inquiry's upcoming public hearing into abuse in the care of the Hospitaller Brothers of St John of God (Order of St John of God) at Marylands School, the St Joseph's orphanage and the Hebron Trust. It relates only to this hearing. <a href="Practice Note 6 - Public Hearings">Practice Note 6 - Public Hearings</a> sets out further directions on public hearings.

## **Timetabling**

- 2 The Hearing will commence on Wednesday 9 February 2022. The Hearing will be located at the Commission's hearing room at Level 2, 414 Khyber Pass Road, Newmarket, Auckland.
- 3 The Hearing is scheduled to finish on 17 February 2022 and will run from 10:00am to 5:00pm on 9-11 and 17 February and 9:45am to 5:00pm on 14-16 February. There will be a lunch break between 1:00pm and 2:15pm, subject to any further directions by the Chair.
- 4 A proposed hearing schedule is attached to this Minute at Appendix A. This hearing schedule may be subject to change.

## **Opening and closing statements**

- 5 Subject to any changes directed by the Inquiry:
  - a. Counsel for each core participant is permitted a maximum of 10 minutes at the commencement of their section of the hearing to make an opening statement.

This will occur directly after the opening statement of Counsel Assisting the Commission.

- b. Core participants (whether in person or by counsel) are permitted a maximum time of 30 minutes for oral closing submissions on Thursday 17 February 2022.
- c. Should Counsel for core participants and those granted leave to appear wish to file written closing submissions, they should be filed no later than 5pm Wednesday 16 February 2022.

## Directions relating to questioning of witnesses

- 6 <u>Practice Note 6 Public Hearings</u> sets out the process for applications for leave to question witnesses. These applications must be made no later than 10 working days before the beginning of the public hearing.
- 7 An application for leave to question Dr Mulvihill and Detective Superintendent Peter Read on certain topics was filed by the Bishops and Congregational Leaders in Aotearoa New Zealand through Te Rōpū Tautoko and was granted on 26 January 2022.
- 8 In relation to questioning witnesses, the following directions are made, subject to further directions at the hearing as required:
  - a. Where a witness is scheduled to give evidence for a half-day, evidence in chief should take no more than 45 minutes.
  - b. Where a witness is scheduled to give evidence for a full day, evidence in chief should take no more than 1 hour.
  - c. Where a witness is scheduled to give evidence for a different amount of time, the Inquiry will notify their counsel of the amount of time they may use for questioning.
  - d. The Commissioners and Counsel Assisting will have the opportunity to question the witnesses.
  - e. Any further questioning will be determined by the Chair.

## Protocol for document management in hearing

9 The Inquiry may use hearing presentation technology to enhance access to documents referred to at the public hearing, making this more accessible to all participants, including the public via livestreaming.

10 If a party wishes any words, paragraphs, sections or other parts of any document to be highlighted when displayed on the screen, they must clearly be identified to the Inquiry when

providing the document. Communications relating to this should be emailed to

11 Should a matter arise during the hearing resulting in a party wishing to have any further

document/s displayed electronically on the screen, the Inquiry will make all reasonable

endeavours to facilitate that, but parties are requested to provide as much notice as possible,

and a minimum of 24 hours' notice is requested.

12 Any document that is produced for presentation via technology will be taken to be provided

on the basis the full document (i.e., not just the part displayed on the screen) can be made

publicly available on the Inquiry's website at the conclusion of that witness's evidence,

subject to a minimum 72-hour delay (but at the sole discretion of the Inquiry) to ensure

compliance with any s 15 orders or agreed redactions.

**Section 15 Inquiries Act Orders** 

13 The Inquiry has issued a General Restriction Order and Practice Note - Section 15 Orders -

Anonymity and Redactions reissued on 2 September 2020. The provisions in those

documents apply. They are publicly available on the Inquiry website.

14 Parties may apply for s 15 orders if they consider that necessary. These applications should

be received no later than 28 January 2022 to enable time for consideration by the Inquiry

and any additional orders to be issued prior to the commencement of the hearing.

Religious attire

15 The Inquiry directs that religious attire or uniforms are not worn by anyone attending the

public hearing, including witnesses. Such attire may be triggering for survivors, and survivor

well-being is integral to the work of the Inquiry.
